

Possession of child ponrography (29 Counts), contrary to the provisions of Section(s)

827.071 (5), Florida Statutes. Affiant's reasons for so believing are as follows:

Your affiant is employed as a Detective with the Clay County Sheriffs Office and has been employed by the Sheriffs Office for the past 19 years. My investigation revealed that the defendant, Jarred Harrell possessed child pornography on his computer located at 2040 Wells Rd. Apartment 14E Orange Park Florida. Jarred was asked to move out of his residence on 8-4-09 after his roommates found that he was responsible for the theft of one of his roommates IPOD touch. Jarrod moved out of the residence leaving his computer and a box of compact disks behind. While Jarred was gone the roommates got into Jarred's computer and searched for child pornography. They searched after they had been told that Jarred had been caught viewing child pornography and a file named "Toddler Insertion". The roommates were also looking for images that Jarred possibly had taken of Jarred's [redacted]. They had opened all of the images and described one of the images that they saw as a nude white female child between 6 and 8 years old sitting down on the floor with her legs spread. The child also had a banana in her mouth. They had found a compact disk in Jarred's box of CD's with the writing "don't lose music" on it. A check of the compact disk revealed that there was a large quantity of child erotica and pornography on the disk. The computer was turned over to the Jacksonville Sheriffs Office the following day on 8-10-09. The computer was processed by the Office of The Attorney General Cyber Crimes Unit after a search warrant was obtained. The forensic processing of the computer revealed a large amount of child erotica and also child pornography. There were 24 pornographic images of children and 5 movies that contained child pornography. A description of one of the movie files is of two white female children between the ages of 10 and 13 years old. The children are dancing in front of the camera clothed. They continued to dance in front of the camera as they take off their clothing down to their G-string underwear. The children would kiss each other and spread their legs for the camera. The children were rubbing ice cubes and baby oil on each other. The movie file is 21.06 minutes long. Another movie is of two white female children between the ages of 9 and 12 years old. The children will be dressed in belly dancing costumes. The children dance to the music and disrobe down to G-string underwear. The children suck on each others toes and feet. They put yogurt on each others feet and lick it off. The children continue to rub each others bodies. A discription of several images are of a female child laying face down on a bed. The female child had underwear pulled down with her legs spread. The forensic examination also revealed that there were 15 images of child pornography that had been deleted from the computer.
