

NARRATIVE

On 01/13/10 at 2158 hrs I responded to the location of 681 E Commercial Blvd (Walgreens) in the City of Oakland Park in reference to a animal abuse. Upon arrival I met with victim/reportee UECCHIO, DANIELLE who advised that her two year old brown Hound Retriever "Zoe" was killed by her friend JONES, WILLIAM (02/04/54).

Victim/reportee advised the following: About a year ago she was not allowed to have her dog "Zoe" at the new place that she moved to. She asked a close family friend of her JONES, WILLIAM (02/04/54) to see if she could keep Zoe at his place and he advised that it would be fine to let the dog stay there. She advised that she gave him money to take care of the dog while it was there for food, shots and tags. She stated that she would come to visit her dog when she could. She stated that on today's date 01/13/10 she was told by JONES, WILLIAM (02/04/54) that her dog had died and she need to come pick the dog up. When she asked Jones what had happened he was not able to give her a explanation. When she arrived at Jones's house the dog was wrapped up in a white sheet and sewed closed. She was also advised by Jones to "pour lys on the dogs body to make it decay faster". She then took her dogs body (Zoe) to her boyfriends house RADER, DAVID in hollywood to bury her in the back yard.

I then spoke to HAIRE, CHARLES (09/13/69) who advised the following: On 01/11/10 the dog Zoe got out out the fenced in back yard through a hole in the fence and was in a neighbors yard running around. On 01/12/10 Zoe again got out of the back yard fence though the hole in the fence. He stated that Zoe got a small laceration on her chest about 3-4 inches long and not that deep from a nail in the fence. When he showed his roommate JONES, WILLIAM (02/04/54) the cut on the dogs chest, Jones got super glue and glues the laceration shut. On today's date 01/13/10 around 0900 hrs Zoe got out through the hole in the fence again and reopened the laceration on her chest again so Jones grabbed the dog and brought it inside of the house. Jones then placed the dog on a coffee table and told Haire to give it one of his muscle relaxant (Colipin 1mg). He then stated that Jones then got a needle and dental Floss and stated that he was going to sew the laceration shut. The dog would not calm down so Jones told his daughter JONES, AYSE (03/28/83) and Haire to hold the dog down. The dog would not stop moving so Jones the got a cloth or a shirt and placed it around the muzzle of the dog and told JONES, AYSE (03/28/83) to hand him the bottle of chloroform and poured some on the cloth that was around the muzzle of the dog. He then advised that the dog stop breathing so Jones tried to give the dog CPR by was unable to revive the dog. He then advised that Jones wrapped up the dog in a white sheet, sewed it close and was going to bury the dog in his back yard but he asked Jones "what are you going to tell UECCHIO, DANIELLE" and he advised that he would tell her "the dog ran away". He stated that Jones called her and advised her that her dog died and need to come pick it up but would not tell her what had happened. He stated that UECCHIO, DANIELLE came and got her dog. Later in the day Haire got UECCHIO, DANIELLE cell phone number and advised her what had really happened and what Jones tried to do.

I gave UECCHIO, DANIELLE a case card and advised her that a report would be completed in reference to this incident.

A copy of the report was faxed to Abuse and Neglect.

PROBABLE CAUSE AFFIDAVIT

Before me this date personally appeared Michael A. Vagnal who, being first duly sworn, deposes and says that on the 11-13 day of JAN. 2010, at 5711 N.E. 7 TR., OAKLAND PARK, FL (crime location), the above named defendant committed the above offense charged and the facts showing probable cause to believe same are as follows:

THAT THE DEFENDANT WAS A CARETAKER OF THE VICTIM ANIMAL, A HOUND/RETRIEVER MIX BREED DOG NAMED "ZOE" (PRONOUNCE ZO-EE). THE DOG WENT THROUGH A FENCE CAUSING A LACERATION OF ABOUT 4 INCHES TO HER CHEST. THE DEFENDANT USED "SUPER GLUE" TO TRY TO SEAL THE WOUND TOGETHER. THE WOUND ON THE DOG WAS REOPENED WHEN SHE WENT THROUGH THIS FENCE AGAIN. THE DEFENDANT, AT THIS TIME, PERFORMED AN AMATURE SUTURE SURGERY TO THE DOG USING DENTAL FLOSS AND A NEEDLE. AS THE NEEDLE WAS PUNCTURING THROUGH THE DOG'S SKIN AND COAT, THE ANIMAL WAS HEARD TO BE "SCREAMING" AND YELPING. THIS WAS AN INTENTIONAL ACT THAT CAUSED THE DOG EXCESSIVE OR REPEATED INFLECTION OF UNNECESSARY PAIN AND SUFFERING (COUNT #1). (SEE PAGE 2)

Vadnal who being first duty sworn deposes and says that on the 11-13 day of January, 2010 at 5711 N.E. 7 Terrace, Oakland Park, the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

WHILE THE DEFENDANT WAS PERFORMING THIS AMATURE SURGERY TO THE VICTIM DOG, THE DOG WAS MOVING ABOUT AND WOULD NOT STAY STILL. THE DEFENDANT MADE A COMMENT TO THE DOG ABOUT STABBING HER WITH A PAIR OF SCISSORS.

THE DEFENDANT THEN PUT A SOLUTION ON A T-SHIRT THAT HE SAID WAS CHLOROFORM IN AN ATTEMPT TO CALM THE DOG DOWN. HE PUT THIS T-SHIRT ON THE DOG'S MUZZLE IN AN ATTEMPT TO DO THIS. THE DEFENDANT THEN Poured MORE OF THIS SOLUTION ONTO THE DOG'S MUZZLE AND, SHORTLY AFTER THIS, THE DOG BECAME STILL AND DIED. THE DEFENDANT COMMITTED AN INTENTIONAL ACT TO THE VICTIM DOG CAUSING THE DOG EXCESSIVE OR REPEATED INFLICTION OF PAIN AND SUFFERING AND AN ULTIMATE CRUEL DEATH (COUNT #2).
